



Recommendation for Lifesaving or Meritorious Action Award

Upon consideration of the evidence submitted from all sources, as set forth in this application, we respectfully recommend that the National Court of Honor grant the award checked below. **Note: If the action being considered is deserving of merit but does not qualify for a national award, do not submit this form. The Local Council Certificate of Merit, No. 606760, is suitable for this purpose.**

Instructions

1. This application must be used.
2. Provide the full name of applicant to be honored, exactly as it should appear on the certificate if the award is granted.
3. Provide as much information as necessary using the space provided on this form. **No additional documents should be attached.**
4. All recognitions are reserved for members who were registered at the time of the action.
5. Lifesaving actions or meritorious actions performed as part of the duty of a trained lifesaver—i.e., doctor, nurse, lifeguard, first responder—will not be considered.
6. Boy Scouts of America employees are not eligible.
7. **No case should be forwarded to the council without a signed statement from the applicant and an eyewitness.**
8. **No application may be considered after a lapse of 36 months of the incident.**
9. Separate applications are required if more than one member is being recognized for recognition.
10. The council committee must investigate the case, interview the principals and witnesses, secure necessary signed statements, and make a recommendation based upon full knowledge of the facts. It is recommended that this committee meet within 30 days of the receipt of the recommendation.
11. The council committee bears the responsibility to write a summary of the event and complete the application in detail that pertains to the case.
12. **Upon approval of the council committee and Scout executive, the council will submit this application electronically to awards@scouting.org.**

LIFESAVING AWARDS (See clause 1.)

These awards recognize the attempt to a save life and an accompanying measure of risk to self.



Honor Medal With Crossed Palms. The individual has demonstrated unusual heroism and extraordinary skill or resourcefulness in saving or attempting to save a human life at extreme risk to self. **“Extreme risk” shall mean of greatest severity to one’s self.**

Honor Medal. The individual has demonstrated unusual heroism and skill or resourcefulness in saving or attempting to save a human life at some risk to self.

MERITORIOUS ACTION AWARDS (See clause 2.)

These awards recognize notable acts of service that need not involve attempts of rescue or risk to self but put into practice Scouting skills and/or ideals.



Medal of Merit. The individual has performed an act of service of rare or exceptional character that reflects an uncommon degree of concern for the well-being of others.



National Certificate of Merit. The individual has performed a significant act of service that is deserving of special recognition.

**RULES AND REGULATIONS
of the
BOY SCOUTS OF AMERICA**

Article X, Section 5, Clause 1
Lifesaving Awards

Clause 1. Lifesaving Awards. Recognition may be given to a youth member or adult leader of the Boy Scouts of America where the evidence presented to the National Court of Honor, in accordance with prescribed regulations, shows that he or she saved or attempted to save life under circumstances which indicate heroism and risk to self. The court will give consideration to resourcefulness and to demonstrated skill in rescue methods. In no case shall recognition be given where it appears that the risk involved was merely in the performance of duty or the meeting of an obligation because of responsibility to supervise and give leadership to the persons whose lives were saved. The awards are:

- a) **Honor Medal With Crossed Palms.** The Honor Medal With Crossed Palms may be awarded in exceptional cases to a youth member or adult leader who has demonstrated unusual heroism and extraordinary skill or resourcefulness in saving or attempting to save life at extreme risk to self.
- b) **Honor Medal.** The Honor Medal may be awarded to a youth member or adult leader who has demonstrated unusual heroism and skill in saving or attempting to save life at considerable risk to self.

**RULES AND REGULATIONS
of the
BOY SCOUTS OF AMERICA**

Article X, Section 5, Clauses 2 and 3
Meritorious Action Awards

Clause 2. Meritorious Action Awards. Recognition may be given to a youth member or adult leader where the evidence presented to the National Court of Honor, in accordance with prescribed regulations, shows that a significant or outstanding act of service, of an exceptional character, was performed. The action taken need not involve attempts of rescue or risk to self but must put into practice Scouting skills and/or ideals. Recognition shall not be given where it appears that the action involved was merely in the performance of duty or the meeting of an obligation. The awards are:

- a) **Medal of Merit.** The Medal of Merit may be awarded to a youth member or adult leader who has performed an act of service of a rare or exceptional character that reflects an uncommon degree of concern for the well being of others.
- b) **National Certificate of Merit.** The National Certificate of Merit may be awarded to a youth member or adult leader who has performed a significant act of service that is deserving of special national recognition.

Clause 3. All applications should be submitted to the National Court of Honor through a local council upon duly prescribed forms, and it shall be within the discretion of the National Court of Honor to determine which type of recognition, if any, shall be given. Recipients of these awards must be registered members of the Boy Scouts of America at the time the action was performed. Awards are made in the name of the Boy Scouts of America.
